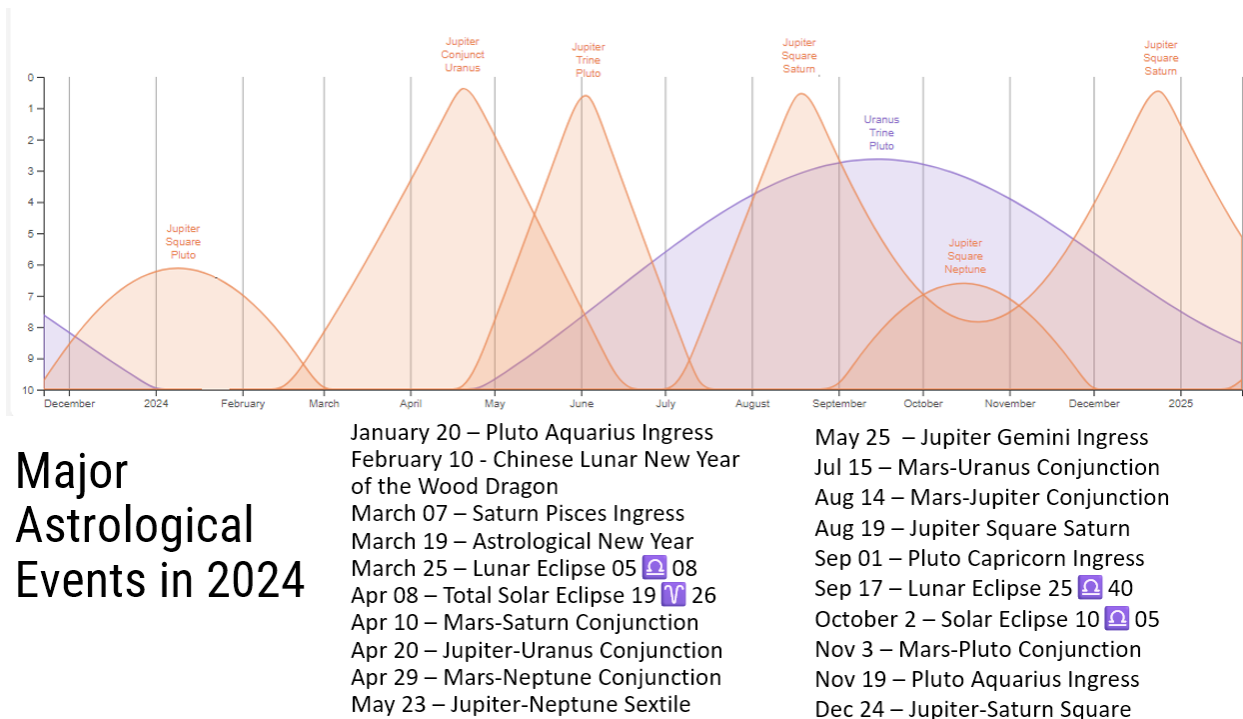

1.1 Introduction

As we approach the end of the year, we have only a few planetary alignments left (Figure 1). Recently, we experienced a solar eclipse on October 2 at ten degrees of Libra. This followed the lunar eclipse in September, along with the "eclipse twilight zone" that stretched from September 17 to October 2. That period was marked by numerous pivotal events, especially concerning the upcoming election.

As we look ahead to November, the Mars-Pluto conjunction on November 3 and Pluto's ingress back into Aquarius on November 19 is expected to bring a surge of political and social activity on a global scale. Significant historical events, including recounts in the US election, are likely.

On December 24, we will witness a Jupiter-Saturn square, bringing discussions of the recession to the forefront. Information from the October eclipse will confirm that the

recession likely began in August. The Jupiter-Saturn square marks when any plausible deniability surrounding the recession will dissolve, and the harsh reality will become undeniable.

1.2 Review of Recent Events

Eclipse periods, especially in the fall, tend to have a more powerful influence, primarily because they coincide with the end of the year when commercial activity is at its peak.

The mundane impact of an eclipse often includes unexpected turns, the exposure of hidden truths, and dramatic strategic shifts. We may witness sudden reversals in fortune, such as "zero to hero" or "hero to zero" moments, changes in alliances, and a drastic shift in public sentiment. These periods also tend to activate hidden agendas, cause wake-up events like hurricanes in North Carolina, and lead to instability in collective psychology. They often bring dramatic and unanticipated developments.

For example, the Federal Reserve cut interest rates by 50 basis points within 24 hours of the eclipse. Historically, such actions have led to major crises, such as the dot-com bubble in 2000 and the global financial crisis in 2008.

In the 14-day lead-up to the recent eclipse:

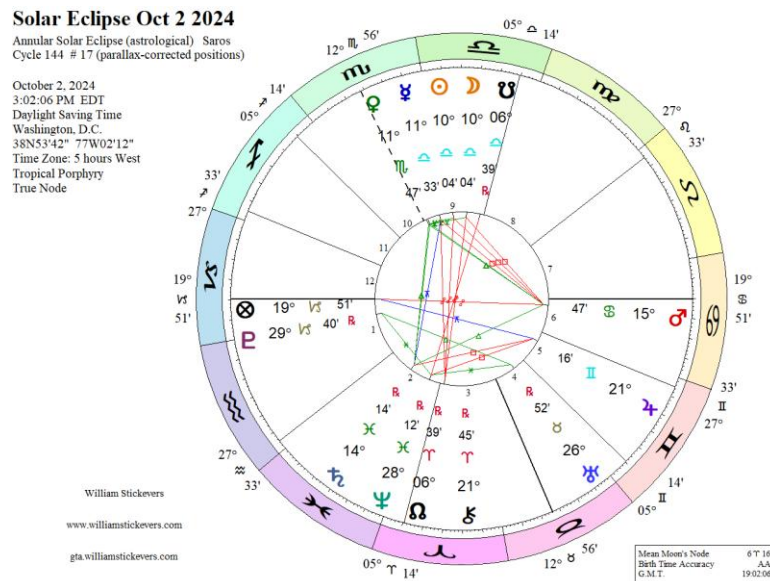
- **September 17-27:** The Fed initiated aggressive monetary easing with supersized rate cuts, while gold prices reached all-time highs and 10-year Treasury yields rose.
- **September 17-18:** A massive cyberattack killed 32 people and injured over 3,200 after devices used by Hezbollah militants exploded.
- **September 20:** Israel assassinated Hezbollah leader Ibrahim Agil and ten others during heightened fighting in Beirut.
- **September 23:** Israeli airstrikes caused the deadliest day of the Hezbollah-Israel conflict since 2006, with 569 dead and over 1,800 wounded.
- **September 25:** China injected RMB 1 trillion (\$142 billion) into large state banks to prevent economic collapse, worsening the situation.

- **September 26:** North Carolina announced that over 747,000 registrants had been removed from the voter rolls due to ineligibility since the start of 2023.
- **September 27:** The Israeli Air Force bombed Hezbollah's central headquarters in Beirut, targeting Hassan Nasrallah, though his condition remains unclear. Israel also prepared for a ground invasion of Lebanon.
- **September 27:** Moscow engaged in secret talks to supply missiles to Iran-backed Houthis, while Trump met Zelensky, suggesting it was time to settle Russia's war in Ukraine.

2.1 The Eclipse

The October 2 annular "Ring of Fire" solar eclipse occurred when the moon was slightly too far from Earth to completely cover the sun, creating a brilliant ring of sunlight around the moon's silhouette (Figure 2).

Events surrounding an eclipse tend to be memorable, with a time frame that can extend ten days before and after the event. Unexpected and fated events may happen as early as 14 days before an eclipse, while solar eclipses can have a lasting influence, sometimes up to three months before the eclipse and extending up to a year afterward.

This eclipse took place over Argentina and the Pacific Ocean, with a direct astrological hit to Neptune, notably impacting Israel's situation. During this period, Israel launched attacks on Hezbollah in southern Lebanon, while tensions between northern Israel and Hamas in Gaza continued to escalate. There is the potential for the US and Iran to become involved in the conflict. Historically, Israel and Iran have never been at war, making this an unprecedented "red zone" moment—an occurrence not seen in 5,000 years (Figures 3 & 4).

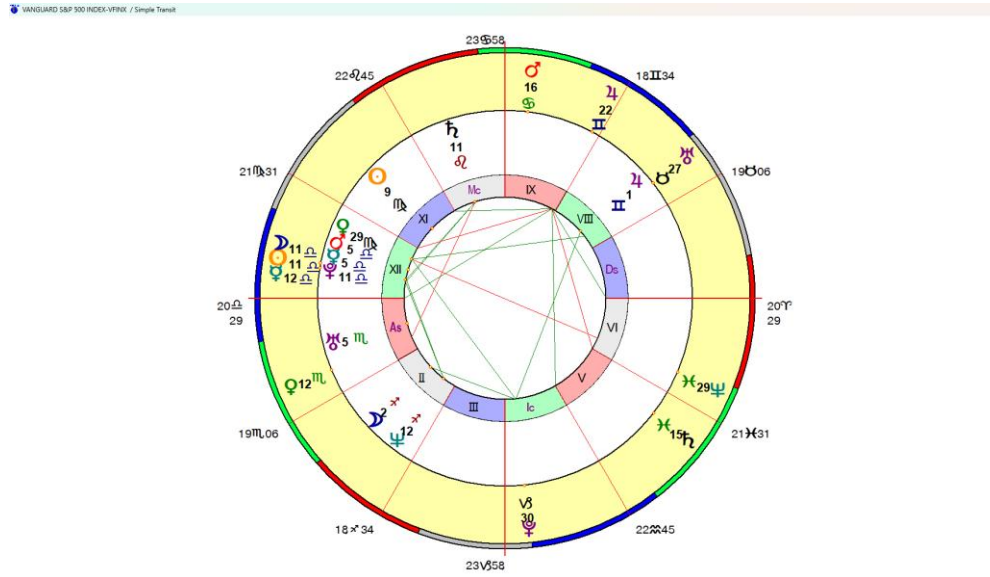
The eclipse also coincided with major escalations in Ukraine, further intensifying global instability (Figure 5).

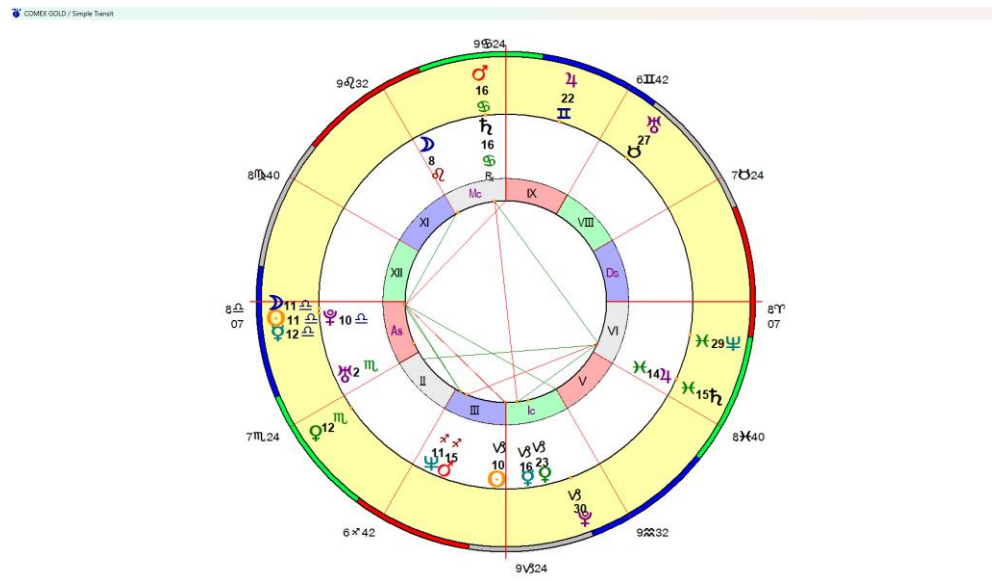


The stock market faced significant setbacks during this time, and astrologically, the eclipse's impact on Pluto was akin to a DEFCON 5 warning (Figure 6).

Meanwhile, gold prices surged for a third consecutive week, reaching new record highs (Figure 7). Even Costco's gold bars sold out despite rising prices. People increasingly turn to gold and Bitcoin as safe-haven assets, signaling that the eclipse may point to deeper economic issues. Regions such as Wisconsin, Michigan, and Pennsylvania have also been severely impacted during this turbulent eclipse period.

2.2 The Eclipse Effect

Hurricane Helene has caused between 200 and 1,000 fatalities, with the crisis worsening due to the diversion of \$640 million in FEMA funds toward services for undocumented immigrants. This reallocation has left the agency severely underfunded for disaster relief. Despite this, Vice President Kamala Harris announced that the FEMA relief package would provide only \$750 per household, which has drawn widespread criticism.

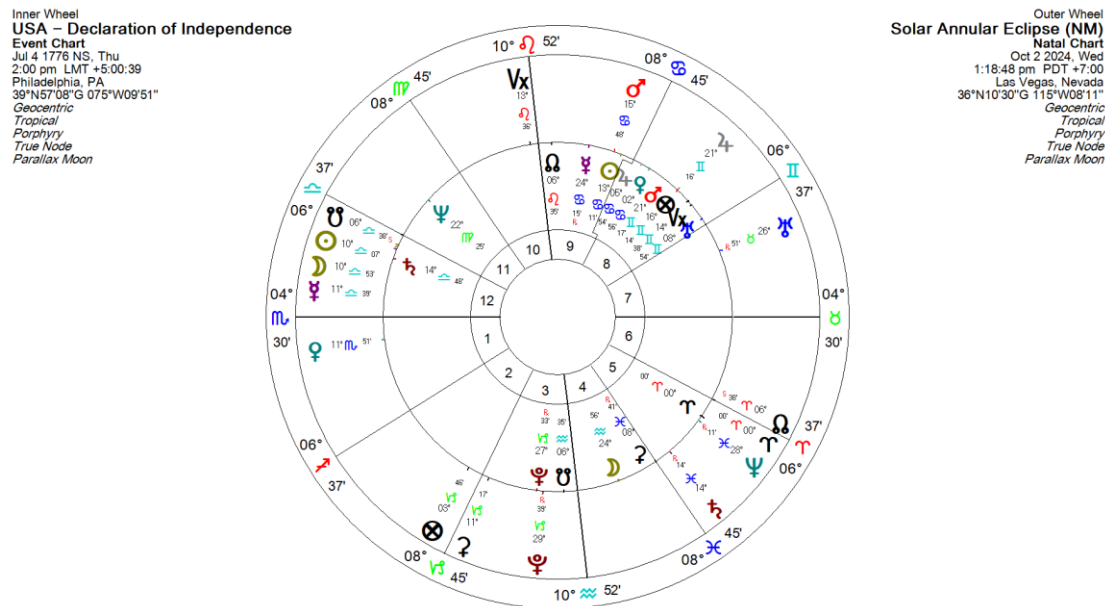
The Biden-Harris administration's "America Last" policies are being blamed for the nation's lack of preparedness during crises, as billions of dollars have been sent abroad. The October 2 eclipse highlights this mismanagement. Meanwhile, the McKelvey Recession Indicator was triggered on the eclipse day. This indicator, which measures the difference between the 3-month average unemployment rate and the 12-month low, signals that a recession has begun when this difference reaches 0.3. With a reading between 0.4 and 0.5, the odds of a recession increase to 52.94%. As a result, many are

shifting their money into gold and Bitcoin as inflation erodes bond values, making these assets appear more secure in uncertain times.

In a bombshell revelation, Michael Shellenberger's article exposed new whistleblower claims about a secret Department of Defense crash retrieval and reverse engineering program known as "Immaculate Constellation." This program involves alternative propulsion systems and zero-point energy technologies and has been illegally concealed from Congress through unconstitutional, unacknowledged special access programs. These revelations are described as a secret even bigger than the Manhattan Project.

The October 2, 2024, solar eclipse profoundly affected the United States, occurring in the 12th House of the USA Independence Chart and squaring the USA's natal Sun (Figure 8). In Mundane Astrology, this alignment signifies hidden forces, leadership challenges, and national identity issues coming to light. Themes such as secrecy, political scandals, leadership shifts, and espionage are expected to dominate as the nation's leadership is forced to confront the hidden elements.

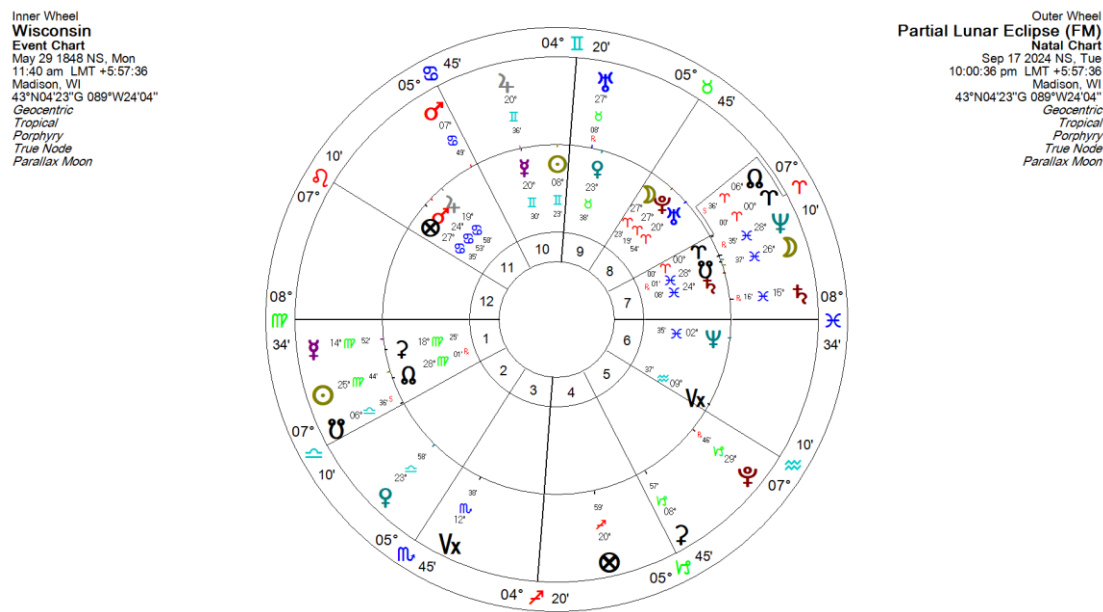

The solar eclipse also brought a shift in the electoral landscape. Based on Trafalgar and Insider Advantage polling, Donald Trump now leads by 2.2 points in Pennsylvania and Michigan and by 1.1 points in Wisconsin, all key battleground states for Kamala Harris. The current Electoral College projection shows Trump with 296 votes to Harris's 226. Since October 2, Trump's chances of winning have improved, while Harris's lead has diminished significantly, especially in Wisconsin.

Wisconsin, in particular, has been heavily affected by the eclipse. The state's partial lunar eclipse directly hit its natal Saturn, marking a significant turning point as Wisconsin undergoes a Saturn return (Figure 9).

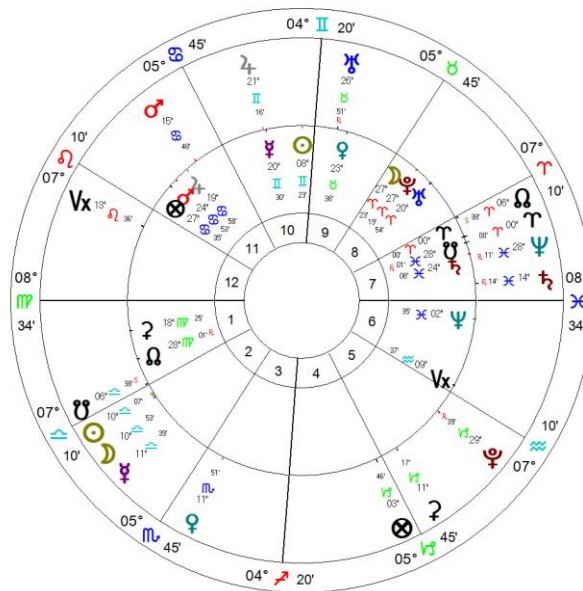


Kamala Harris is losing voter momentum within this eclipse zone, and recent developments have pushed the state from "lean Harris" to "toss-up" status. The Wall Street Journal shows Trump leading Wisconsin by 3 points, further solidifying his gain since the October 2 solar eclipse. The state's residents are signaling a desperate need

for change, as transiting Uranus, conjunct with Algol, aligns with Wisconsin's Venus, and transiting Jupiter conjuncts its Mercury, indicating dissatisfaction with the current status quo (Figure 10).

3.1 The Political Landscape

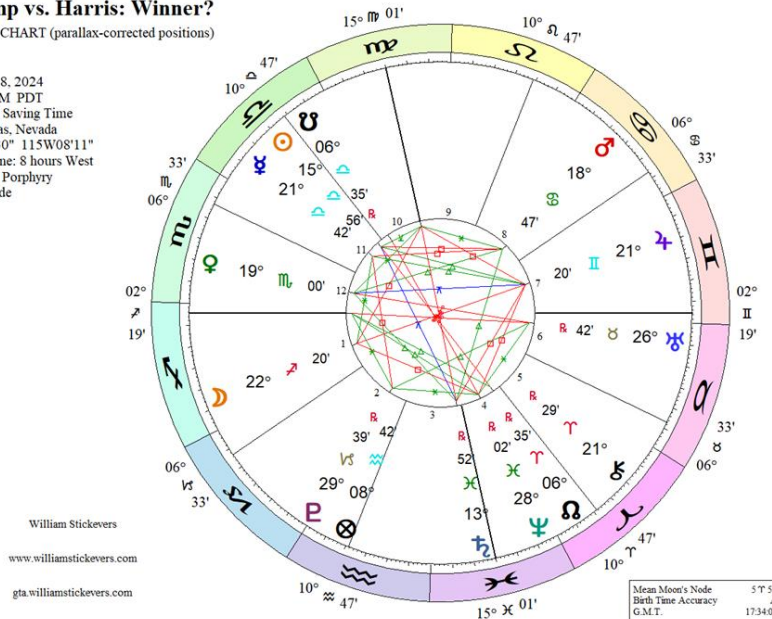
In the 2024 US presidential race, Donald Trump held a narrow lead over Kamala Harris, with polls showing him at 50.6% to Harris's 48%. Several astrological factors come into play as the election nears (Figure 11).

The Ascendant represents Trump, Sagittarius at 2 degrees 24'06", with its ruler, Jupiter, positioned at 21 degrees Gemini in the 7th house, symbolizing his opponent. Harris, as the underdog, is represented by the descendant, Gemini, at 2 degrees 24'06", with its ruler, Mercury, located at 21 degrees Libra in the 11th house.

Factors Favoring Trump: The Solar Eclipse on October 2, 2024, took place in the 12th House of the USA Independence Chart, forming a square with the USA's natal Sun. This configuration is highly significant in Mundane Astrology, particularly regarding national identity, leadership, and hidden forces. The eclipse brings to the surface

themes of secrecy, hidden enemies, political conspiracies, and revelations, creating tensions between the country's leadership and the shadow elements behind the scenes. This favors Trump, as he represents the figure rising amidst these dynamics.

Factors Favoring Harris: Mercury, which represents Harris, is in a stronger position by house and dignity than Trump's Jupiter, which is in detriment in Gemini and positioned in Harris's house (the 7th house). This suggests that Harris could perform better than expected on Election Day, possibly resulting in a closer contest than the current polling suggests. Mercury's placement gives her the potential to gain ground.

Challenges for Trump: The south node in the 10th house, representing public reputation and leadership, indicates potential difficulties for the Electoral College winner, which could impact Trump's chances. Since the south node is in Libra, Harris's sign, this may hint at claims of fraud or disputes over the results, particularly from the Democrats. Additionally, Jupiter's detriment in Gemini weakens Trump's standing, suggesting that his influence may be waning or that his policies are viewed as out of touch with current realities.

Challenges for Harris: Mercury, Harris's ruling planet, is combusting the Sun, which signals that she is weakened. This indicates that her position may become more vulnerable as Election Day approaches. The Moon's alignment with Trump's sign and the ascendant points to undecided voters leaning toward Trump as the election draws near, creating additional pressure on Harris's campaign.

In summary, while Trump currently holds an advantage, astrological factors suggest that Harris could narrow the gap. Both candidates need help with significant challenges, with Trump contending with waning influence and Harris battling diminishing momentum.

3.2 Possible Scenarios

In the 2024 US Presidential election, the early ascendant degree (0-3 degrees) in the astrological chart adds a layer of uncertainty to the outcome. While Trump holds a 65% chance of winning and is favored, the early ascendant suggests that the full picture has not yet emerged. It implies that new information or changes in circumstances may still surface, potentially altering the direction of the contest. This means that caution should be taken when making predictions, as eclipses often reveal hidden factors that could affect the final outcome.

Harris has a 35% chance of winning, but her position remains weakened due to Mercury's combustion, symbolizing that her campaign is currently under pressure. However, the early ascendant hints at unexpected opportunities for Harris. These could slightly increase her chances for a shift in her favor, indicating that while Trump is in a stronger position, emerging factors could still influence the final result.

Kamala Harris's Winning Scenario:

- **Improved Visibility and Momentum:** Harris needs to break free from the "shadow" created by Mercury's combustion. She can do this by dominating key news cycles and focusing on critical voter issues that resonate with the electorate.
- **Strategic Electoral Play:** Harris must concentrate on swing states and fine-tune her Electoral College strategy. The South Node in the 10th House could offer an opportunity to shift the electoral system in her favor.
- **Emotional Connection and Voter Mobilization:** Harris should appeal emotionally to undecided voters, especially targeting marginalized groups, including young voters, people of color, and single women. Mobilizing these groups could provide a significant boost to her campaign.
- **Capitalize on Opponent's Weaknesses:** Harris's team should identify and exploit vulnerabilities in Trump's campaign. Any perceived weaknesses or missteps could help shift the momentum toward her.

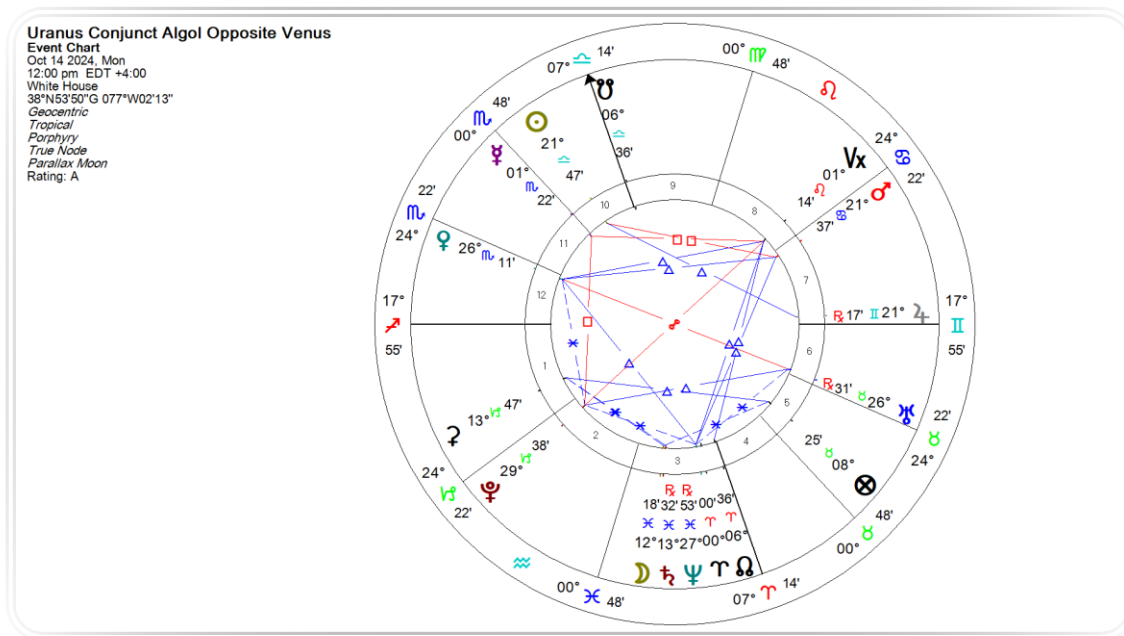
As a result, while Trump has the upper hand, Harris still has pathways to victory, especially if new developments or revelations shift the dynamics of the race. Nobody knows the outcome for sure, but it may seem that the democratic party is now panicking.

4.1 Themes and Precedents

The Year of the Dragon has historically been associated with dramatic changes and unexpected events, often influencing primary political outcomes. In the 2024 US election context, parallels are drawn to the 1988 election, where George H.W. Bush, initially underestimated, managed to secure a decisive victory. Similarly, in 2024, while the perception may lean toward Kamala Harris winning, the dynamics suggest that Donald Trump could be parallel to Bush, achieving a surprise win despite the odds.

On October 14, 2024, the astrological landscape is marked by significant events that suggest a period of upheaval and change. The conjunction of Uranus and Algol is particularly noteworthy (Figure 12). Algol is often associated with themes of destruction and turmoil, while Uranus embodies sudden shocks and radical innovation. This potent conjunction is a powerful symbol of potential disruption, which could manifest in various forms, such as a geopolitical crisis, a natural disaster, or social unrest. It may indicate a time of political transformation, where traditional voter loyalties are shaken, and established alliances are at risk of being broken.

In addition, Venus's opposition to Uranus signals a shift in public opinion, suggesting that unexpected developments are likely to arise during the campaign. This aspect aligns well with former President Trump's propensity for thriving in unpredictable situations, potentially resulting in defections from the Democratic Party and enhancing his chances in the upcoming election.

The political climate is further complicated by concerns surrounding the "Deep State," with suggestions that the political establishment is apprehensive about Trump's resurgence. Reports indicate that Vice President Kamala Harris's approval ratings may be as low as 15%, reflecting a sense of desperation among certain factions. Meanwhile, the international geopolitical landscape remains tense, with rising conflicts in Ukraine and fears regarding leadership stability, particularly concerning Putin. The specter of nuclear escalation looms over areas like Kursk, raising alarms about its potential implications for global stability.

Key takeaways from these astrological and political dynamics include the likelihood of unexpected shifts akin to those seen in 1988, where Trump could benefit from a sudden surge as voters shift away from the Democratic Party. The conjunction of Uranus and Algol, coupled with Venus opposing Uranus, points to a time of chaos that could swing the election in Trump's favor. Moreover, the narrative of a "Deep State" fearing Trump's return adds another layer of intrigue, raising questions about election integrity and public perception. The unexpected may determine the election's outcome in this volatile astrological and political environment.

4.2 Saturn Neptune Themes and Effects

The Saturn-Neptune conjunction of 2026, which began its orb earlier this year, marks a period of profound societal and political shifts, resonating with historical themes of cultural uprising and systemic upheaval (Figures 13 & 14). This planetary alignment often aligns with significant moments of change, including assassinations, wars, and deep-seated conflicts (Figure 15). The current wave of its influence highlights the tension between control and illusion, structure and deception, as societies grapple with competing forces of order and chaos.

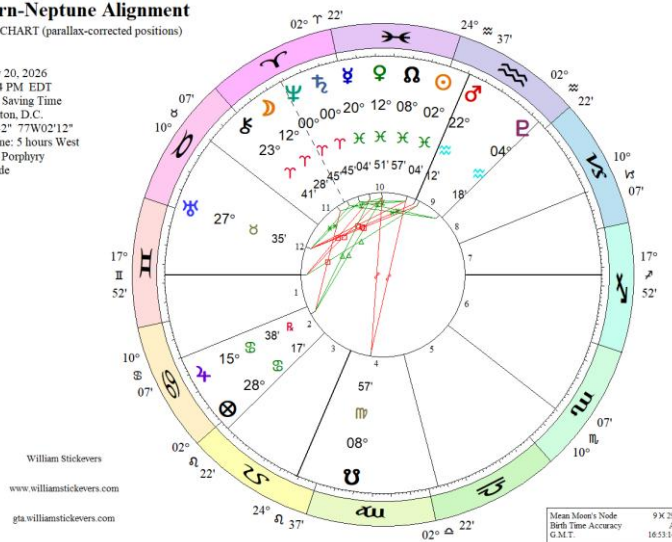

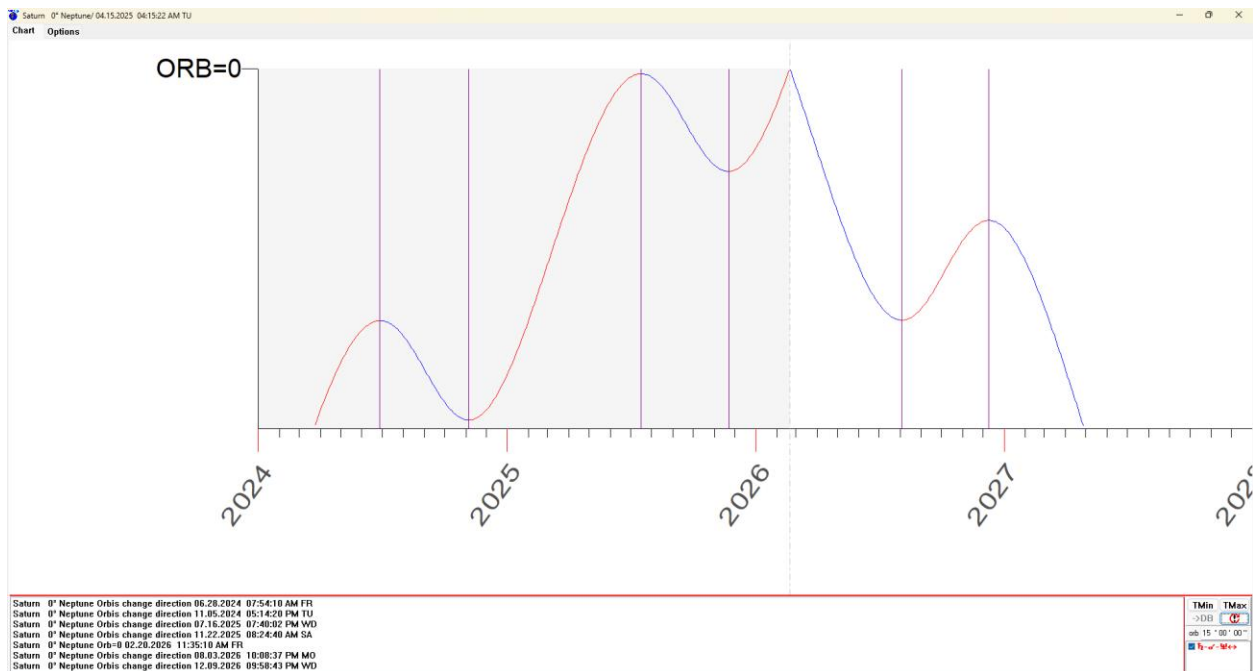
